

Geopolitical Events

It has finally become clear what the powers of darkness of this age intended all along -- the destruction of humanity, not in a direct way, not direct warfare, but their core objective was the Divine Image, to destroy the Divine Image in humanity, via the blood, and thereby bring in death through disease or covert bio warfare using the spiked protein of Sars-Covid2. This is so because people, Americans in general, have rejected knowledge, the fundamental truths of The Holy Book, The Bible, even as Seventh-day Adventists have rejected the repeat of the Three Angels Messages as taught by Ellen G. White, Victor Houteff, Ben Roden and Lois Roden.

Twenty years ago, this month September 2021, the destruction of the Twin Towers in New York City took place. I remember the day well. Everyone does. All air traffic across the USA and Canada, all of Europe, all commercial flights, were grounded within a couple of hours of the attack on the Twin Towers, ordered to land at the nearest airport by the American FAA (Federal Aviation Administration and the Canadian air traffic authority). All planes were directed to find an airport large enough to accommodate large jet aircraft with a long runway, the nearest commercial airport, after the Twin Towers were hit. For commercial planes crossing the Atlantic to the west from Europe and those flying northeast across northern Canada, the large commercial airport in Newfoundland/Labrador within a few hours, early that day, became a massive parking lot for all commercial aircraft on the polar route to and from Europe. That airport became a major story in the news. The hospitality of the people of that far northeast tip of Canada became legendary. The passengers of every flight forced to land there were greeted warmly by the local population and every home became a hotel for passengers without charge.

It became a local emergency there to accommodate all the forced arrivals until the airspace reopened in North America. No one was forced to live at the airport terminal for days. Every local school bus was put into operation to and from the airport. The United States airspace was shut down for days, about a week if I remember right. I remember getting up that night, September 12, in the middle of the night, walking into another room where the window was open, around 2 or 3 in the morning, I quickly heard a jet aircraft in the night sky, likely an American F-15 or F-16 fighter jet, doing a high-speed turn nearly above our home. All American air defense forces were on high alert for days, day and night, on patrol thinking another terror attack from the sky might be imminent. The quietness of that night and the complete shift of national consciousness the day before and world-wide was already emotionally powerful. Everyone was aware and on edge wondering what the days ahead would bring. The quietness that night alone was kind of eerie. The sound of the fighter jet above our house just created more of an unnerving feeling that everything had changed. It had. The fighter jet was doing what was called CAP maneuvers, Combat Air Patrol, over the skies of Southern California, essentially a search and destroy mission, if any civilian aircraft, or commercial plane, happened to be in the sky. Take-offs of any airplane were prohibited by air traffic control for the period of the airspace shut down. Those fighter jets were authorized to shoot down any non-military, non-authorized aircraft for over a week. It was a dramatic moment that night, in the quietest time of the night, underscoring the nature of the world crisis that had emerged, the real beginning of the New World Order which brought about the Patriot Act legislation in the USA thereafter bringing in new and very strict security rules for air travel for all Americans as well as Canada and Europe, and other security provisions that brought about a loss of freedoms. That event was planned and ordained, by the elite masters of the earth, the END of one historical era and the beginning of a New World Order era. This is how they operate and openly declare their intentions to the world.

In New York City it was a massive crisis with first responders frantically searching for survivors in the upper levels of the collapsed buildings for 24 hours a day in three shifts for weeks. First responder teams came to assist the NYC Fire Department from many states across the USA. It was a massive rescue operation until all survivors were found in the rubble. However, in looking at the horrible aftermath of the 911 holocaust we must look at the much bigger picture -- the plan of the enemy to destroy 90 percent of humanity bringing on the time of trouble (Dan. 12:1) along with natural disasters. How will the enemy bring about such a greater horrific mass destruction of human life and end all the God-given freedoms we have long held and enjoyed in the USA? Simple. Through DNA. The Two-Horned Beast

REV. 13:11-18

*As John beheld the vision with intense interest, his attention was directed to another striking object: And I beheld another beast coming up out of the earth; **and he had two horns like a lamb, and he spake as a dragon.**" (Rev. 13:11.) Just about the time the second and last stage of the non-descript beast was to terminate, another earthly power was to come upon the stage of action, according to the vision. It is wonderful to note how accurate the symbols are even to their proper time and order. The beast having lamb-like horns (promise of growth) **is an unmistakable symbol of a nation** "slowly arising as from a small plan to a mighty empire." "Lamb-like," is descriptive of the government arising in 1776 A.D. (See "The Great Controversy," pp. 439-441.) {SR2: 108.1}*

This beast has been accepted as a symbol of the United States. Therefore, our intention is not to bring forth facts pertaining to its application. Our aim is, as previously stated, to briefly connect one beast with another by throwing light upon symbols which have not been understood. {SR2: 108.2}

*It will be noticed that every beast representing the New Testament time has ten horns except this one. We repeat that the ten horns stand as a symbol of universal systems. **This fact proves that the two-horned beast represents a local government.** As civil powers or governments are symbolized by horns, this particular beast having two, it is evident that the nation represented by this symbol, shall have a double form of government. As John says, "The beast spake as a dragon," **it clearly reveals that it is to repudiate its constitution, and the God-given liberty of its subjects will be taken away.** According to Rev. 13:12, this power is to imitate the beast "before him" (the papal rule): "And he exerciseth all the power of the first beast before him, and causeth the earth and them which dwell therein to worship the first beast, whose deadly wound was healed." **If this great nation should presume upon the conscience***

of its subjects by legislation, as to how they may, or may not worship, it would be contrary to the provisions in its constitution -- speaking as a dragon. Quoting the United States constitution, the first amendment concerning religious matters, states: "Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof." If this country should repudiate this amendment, it will completely meet the symbolical specification. {SR2: 108.3}

2TG17:

Unlike the first beast, the second beast comes from the earth. The sea and the earth obviously point to two different locations. We know that the beasts of Daniel 7, and the leopard-like of Revelation 13, the beasts that arose from the sea, all originated in the Old Country, the lands where humanity originated. Yes, the "sea" befittingly symbolizes the Old Country because the sea is the store-house of the waters, the place where the waters originate, as the Old Country is the place from where humanity spread out. {2TG17: 9.3}

*The "earth," then, points to a place away from the "sea" and the opposite of what sea stands for, -- a country made up of inhabitants who have emigrated from elsewhere. **The only such country or nation away from the Old Country and as influential as portrayed in this two-horned beast that arises after the formation of the leopard-like beast, in the Protestant period, is the United States.** Moreover, the United States is already a world power, and so we need not be guessing any more. The beast's two horns point to its two political ruling powers -- Democrats and Republicans. Their lamb-like character gives the appearance of innocence, harmlessness, and charitability. The beast's speaking like a dragon nevertheless repudiates the lamb-like appearance of the horns. {2TG17: 9.4}*

*The two-horned beast exercises all the power which the first beast, the leopard-like, exercised, again showing it to be a world power. **Indeed, it requires just such a power to compel all the inhabitants of the earth to worship as he commands, and to implement a likeness of a church and state government that is as outdated as are the Middle Ages themselves.** Yes, it takes such a power to influence the world, save those whose names are written in the Lamb's Book of Life, to bow down to it. {2TG17: 10.1}*

Rev. 13:13-15 - -"And he doeth great wonders, so that he maketh fire come down from heaven on the earth in the sight of men, and deceiveth them that dwell on the earth by the means of those miracles which he had power to do in the sight of the beast; saying to them that dwell on the earth, that they should make an image to the beast, which had the wound by a sword, and did live. And he had power to give life unto the image of the beast, that the image of the beast should both speak, and cause that as many as would not worship the image of the beast should be killed." {2TG17: 10.2}

*Here you see that this unification of the world, engendered to bring peace and harmony out of the present chaos, will instead bring an even greater time of trouble. And why? -- Because though the beast **may bring Communism and Capitalism to mutual agreement, and cause them to bow down to the image of the beast, yet those whose names are written in the Lamb's Book of Life WILL NEVER COMPLY. From this you see that the whole plan is directed by a supernatural power whose aim is to boycott the people of God. They shall nevertheless be delivered.** {2TG17: 10.3}*

When the beast's decree is passed that no one can buy or sell, and should be killed for non-conformity, then God only can protect His people, the people whose names are written in "The Book." Such is His faithful promise: "And at that time shall Michael stand up, the great Prince which standeth for the

children of thy people: and there shall be a time of trouble, such as never was since there was a nation even to that same time: and at that time thy people shall be delivered, every one that shall be found written in the Book." Dan. 12:1. {2TG17: 11.1}

Rev. 13:16, 17 -- "And he causeth all, both small and great, rich and poor, free and bond, to receive a mark in their right hand, or in their foreheads: and that no man might buy or sell, save he that had the mark, or the name of the beast, or the number of his name." {2TG17: 11.2}

This power, you see, is to control the world's markets, too. {2TG17: 11.3}

This symbolic forecast of the world government to be set up, plainly points out that the coming world government is to be neither the U.N., nor Communism, but an ecclesiastical power. We know that it is not Communism, because Communism is against religion, and the beast is for it. {2TG17: 11.4}

When this comes to pass, which is no longer beyond the horizon, then those whose names are written in the "Book of Life" shall be delivered, but all others will have received the mark of the beast. There will be no middle ground, or middle class. {2TG17: 11.5}

We should now decide what to do, so that we will not be caught off guard. For this very cause the light of Truth has come to us now. {2TG17: 12.1}

The world government which is to develop from the "League of Nations" and the "United Nations," is not actually to be absolutely universal, and there are still to be "two worlds," but rather than there being Capitalism and Communism, they are to be those who worship the beast and his image, and those who worship God and have their names written in the Book. The latter are the only people who will not bow down to the future world government. {2TG17: 12.2}

The Emerging Health Story

Respiratory syncytial virus (RSV) — a respiratory virus that causes typically mild cold-like symptoms — has apparently been selected as the next invisible boogey man. Most children have been exposed to RSV by their second birthday.

The fact that most children survive past the age of 2 tells you something about the risks involved. That said, in very rare cases, RSV can progress to pneumonia or bronchiolitis (inflammation of the small airways of the lungs).

RSV Emerges Out of Season Around the World

According to reports, RSV is now raging around the world, from New Zealand¹ to Japan² and the U.S.,³ where it hit so hard in June 2021 that the Centers for Disease Control and Prevention issued an emergency alert⁴ for parts of the southern United States.

The CDC encouraged testing for RSV among patients who tested negative for COVID-19 but had "acute respiratory illness" symptoms. They also advised health care personnel, child care providers and staff of long-term care facilities to stay home from work if they had respiratory symptoms, even if they test negative for COVID, as they might have RSV.

Like coronavirus, previous efforts to develop an RSV vaccine have met with failure as test subjects have a tendency to die or become seriously ill when exposed to the wild virus, thanks to paradoxical immune enhancement (PIE), also known as antibody dependent enhancement (ADE).

In New Zealand, health officials said there were few cases of RSV in 2020 during the pandemic and, while it's normally a winter disease, it's now making a comeback off-season in 2021. According to Stuff.co.nz,⁵ the outbreak "was more than twofold greater than the historical average from 2014 to 2019 for this time of year."

Similar reports have been published in Japan where, in early July 2021, the National Institute of Infectious Diseases warned of RSV infections outside the normal peak period. According to the Japan Times:⁶

"... the number of RSV patients per medical institution was 3.87 in the week ending June 27 — the highest number of cases since 2019. In 2018, the year the counting system was changed, the infection count peaked in September at 2.46, and it reached 3.45 patients per medical institution a year later."

August 3, 2021, U.S. health officials reported that RSV had started to taper off by midsummer, but a resurgence is now seen, with a "record-breaking 563 new RSV cases" reported in the week before August 3.⁷

FDA Fast-Tracks mRNA Shot Against RSV

That same day, August 3, 2021, the Food and Drug Administration granted fast-track designation to Moderna for an mRNA-based injection against this common cold virus. As reported in a Moderna press release:⁸

"... the U.S. Food and Drug Administration (FDA) has granted Fast Track designation for mRNA-1345, its investigational single-dose mRNA vaccine against respiratory syncytial virus (RSV) in adults older than 60 years of age.

'We are pursuing an mRNA RSV vaccine to protect the most vulnerable populations — young children and older adults,' said Stéphane Bancel, Chief Executive Officer of Moderna.

'We are studying mRNA-1345 in these populations in an ongoing clinical trial and we look forward to sharing data when available ... We have accelerated research and development of our infectious disease therapeutic area and we will continue to advance our mRNA vaccines into new areas of high unmet need.'

Moderna's press release correctly points out that there's no approved vaccine available for RSV. What they don't mention is why. The reason there's no RSV vaccine on the market is the same reason why there has never been a coronavirus vaccine, and that is because none of them were able to pass trials.

As with coronavirus, previous efforts to develop an RSV vaccine have met with failure as test subjects have a pesky tendency to die or become seriously ill when exposed to the wild virus, thanks to paradoxical immune enhancement (PIE), also known as antibody dependent enhancement (ADE).⁹

RSV Shot Builds on COVID Jab

Moderna's RSV shot uses the same lipid nanoparticle as its COVID-19 injection. The primary difference between the two shots is the coding of the mRNA. In the RSV shot, the mRNA encodes for a prefusion F glycoprotein.

Prefusion F protein is a protein that mediates the RSV virus' entry into your cells and is known to elicit a neutralizing antibody response.¹⁰ Under normal circumstances, it's hard to imagine an RSV vaccine built on a novel mRNA platform getting fast-tracked, but we're no longer in normal times.

The rollout of mRNA COVID shots have, as predicted, paved the way for any number of new mRNA-based injections going straight to human trials. So, should you ever feel like your body lacks in synthetic mRNA, fear not. This is just the beginning. Those who embrace vaccine passports will surely find themselves called to the nearest vaccine center several times a year for mandatory refills.

Are We Creating a Public Health Disaster?

The decision to fast-track yet another mRNA injection fails to take into consideration the possibility that we might already be creating an avalanche of ADE-related illness from the COVID shot. Adding another injection for a respiratory virus that has historically been associated with ADE could be extremely risky.

As noted in a September 9, 2020, Nature Microbiology paper titled "Antibody-Dependent Enhancement and SARS-CoV-2 Vaccines and Therapies":¹¹

"Data from the study of SARS-CoV and other respiratory viruses suggest that anti-SARS-CoV-2 antibodies could exacerbate COVID-19 through antibody-dependent enhancement (ADE). Previous respiratory syncytial virus and dengue virus vaccine studies revealed human clinical safety risks related to ADE, resulting in failed vaccine trials ...

ADE can increase the severity of multiple viral infections, including other respiratory viruses such as respiratory syncytial virus (RSV) and measles.

ADE in respiratory infections is included in a broader category named enhanced respiratory disease (ERD), which also includes non-antibody-based mechanisms such as cytokine cascades and cell-mediated immunopathology ...

Furthermore, ADE and ERD has been reported for SARS-CoV and MERS-CoV both in vitro and in vivo ... ADE pathways can occur when non-neutralizing antibodies or antibodies at sub-neutralizing levels bind to viral antigens without blocking or clearing infection ...

ADE has been observed in SARS, MERS and other human respiratory virus infections including RSV and measles, which suggests a real risk of ADE for SARS-CoV-2 vaccines and antibody-based interventions ...

Going forwards, it will be crucial to evaluate animal and clinical datasets for signs of ADE, and to balance ADE-related safety risks against intervention efficacy if clinical ADE is observed."

In case you missed it, the authors specifically point out that ADE can worsen the severity of RSV. Theoretically then, if you get the COVID shot and end up with ADE, then contracting RSV could turn into a far more serious problem than it would otherwise.

Have COVID Policies Weakened Immune Systems?

While the COVID shot could play a role if we start seeing severe RSV in adults, it's unlikely to be part of the equation when it comes to children, as the shot is still not authorized for children under the age of 12. More than likely, the out-of-season rise in RSV among children is related to the easing of restrictions after not being exposed to normal pathogens for extended periods of time.

During the past 18 months, as most of the world has been masked up, locked down and otherwise distanced from one another, children and adults have not been exposed to viruses and bacteria as they normally would.

On the one hand, there has been a significant reduction in the number of people reporting colds, flu and other infectious diseases. On the other hand, some health experts are questioning if this lack of exposure may have increased the risk for some to experience more illnesses as children reenter school and adults reenter the workforce.¹²

The two main parts of your immune system are your innate immune system, which you were born with, and your adaptive immune system, which is developed as you're exposed to pathogens.¹³ A healthy immune system keeps a record of every pathogen to which it has been exposed so that it can quickly recognize it if exposed again. Your immune system is activated when you're exposed to a protein it doesn't recognize, called an antigen.

Since the system is so complex, there are several potential ways in which things can go wrong. If your immune system doesn't work correctly it can result in immunodeficiency diseases, resulting in more and longer-lasting sickness.

Some health experts are concerned that children may have experienced greater harm to their immune system than adults since they have spent the better part of the last 18 months isolated from nearly every exposure.¹⁴

From what researchers are now finding, it is infants and children who may have the most detrimental response to social distancing.¹⁵ Since the beginning of 2020, doctors and hospitals have noticed a significant reduction in the number of bacterial and viral infections children have been contracting. This includes bronchiolitis, measles, varicella, RSV and pertussis.

A paper¹⁶ published in August 2021, from the Pediatric Infectious Disease Group postulated nonpharmaceutical interventions imposed during 2020 could result in larger epidemics of infectious diseases once these interventions are lifted.

Rising Number of Infants With RSV Related to Immunity Debt

Some experts are calling a rising number of RSV infections in babies a "debt of immunity" created because infants born during 2020 had a lack of exposure to normal pathogens.¹⁷ Once infants and children are introduced to these environmental pathogens en masse, it can instigate a precipitous rise in cases.

According to The Guardian,¹⁸ New Zealand reported a 99.9% reduction in flu and 98% reduction in RSV during 2020. This nearly eliminated the spike of deaths that happens during the winter months from flu and RSV. In the short-term, it may have prevented an overload of the health care system while others were being treated for COVID-19.

However, in the long run, it may have created an additional problem in infants and children. When the immune system is not challenged at an early age, it can lead to larger outbreaks, which again taxes the health care system. As of early July 2021, New Zealand had reported nearly 1,000 cases of RSV over five weeks. The usual number reported is 1,743 over 29 weeks.

Doctors are hoping this doesn't necessarily mean there will be more RSV cases, only that they are occurring in more rapid succession early in the season. The current outbreak has stretched the resources in New Zealand and Australia, which is also experiencing a surge in cases. New Zealand's director general of health Dr. Ashley Bloomfield commented to a reporter from The Guardian saying he was:¹⁹

"... certainly concerned about the sharp surge in RSV cases ... There's some speculation that [the current outbreak] may be partly exacerbated by the fact we didn't have any last year and so there is a bigger pool of children who are susceptible to it."

In Canada, Wellington-based epidemiologist Michael Baker warns that his country may also see a similar trend in cases of RSV in the next year, warning that babies who were born prematurely are most at risk.²⁰

That said, while Canada may see a rebound in RSV infections, Baker does not think that a lack of exposure to pathogens at an early age will have "in any way impeded the development of a healthy immune system."

Is a Fast-Tracked RSV Shot the Answer?

Considering the multitude of problems associated with the gene-based COVID shots, I'm not optimistic about the development of a fast-tracked mRNA "vaccine" against RSV. The risks are numerous. Already, we're seeing trends that could signal that ADE is at play in older people who got the jab (but not younger people).

In the U.K., as of August 15, 2021, 68% of COVID patients admitted to hospital who were over the age of 50 had received one or two COVID injections. Mortality statistics reveal the exact same trend. In the over-50 group, 70% of COVID deaths were either partially or fully "vaccinated."²¹

Could this be because older people are developing ADE and therefore suffer more serious infection when exposed to the SARS-CoV-2 virus? In the under-50 category, the unvaccinated make up a majority of hospitalizations and deaths in the U.K., so perhaps the shot affects different age groups differently.

Older people are also the target group of the RSV shot, and infants and young children are a target for both COVID shots and RSV shots. Time will tell what the ramifications of programming the bodies of the very young and the very old to produce more than one antigen might be. But my guess is it won't be good. -- End quote this article.

WHAT IS OUR SPIRITUAL LINEAGE?

With the events taking place today, the “mark of the beast” fully unfolding (well before the Sunday laws), the altering and destruction of our Divinely created biological genes, our DNA (Deoxyribonucleic Acid), what is taking place currently on the world stage, we must now look at the providential cause, the trigger event, the Divine counterpart to this story, what it is and where it developed. We must know the origin of our spiritual birth to know our destiny to claim our rightful place, even our deliverance. The purposeful plan by the enemy is to eradicate the Firstfruit harvest, to prevent the final separation of the professed people of the Advent Movement in the Judgment for the Living.

VTH:

Question No. 68:

Is the church to be purified before the enforcement of the beast's decree as predicted in Revelation 13:15-17? Or will this drastic decree be the means of purifying the church by sifting from her those who are disloyal to the Truth? {ABN3: 69.3}

Answer:

If it be true that the beast's decree is to sift out the unconverted (the tares) that are in the church, then one must conclude that the beast is not a symbol of a power of dragon-like principle, but a heaven-sent agency, sent to cast out the tares which the dragon has brought in! {ABN3: 69.4}

From Ezekiel 9 we see that not the "beast," but the angels are to do this. After the one with the writer's inkhorn by his side marks those who sigh and cry for the abominations that are done in their midst, the five with slaughter weapons follow on to slay all who are left without the mark. And this great purgation, as both the prophecy itself and the Testimonies specifically state, takes place in the church. (See Testimonies to Ministers, p. 445; Testimonies, Vol. 3, pp. 266, 267; Testimonies, Vol. 5, pp. 210, 211; also Tract No. 1, The Dardanelles of the Bible.) {ABN3: 69.5} End quote.

Since 1844 (1831) – the unfolding of the Three Angels' Messages and their repeat phase beginning in 1930 we have a clear path, a great light guiding our pathway, step after step, in the "FIVE DISTINCT Messages prior to the Advent..." as James White wrote in WLF. If the enemy of souls can destroy our bodies, our physical health, destroy our health freedom, our freedom to choose, then the Messages since 1844 are of no value or will fail in producing the end time spiritual Firstfruit harvest.

The Sars-CoV-2 plandemic did not happen in a vacuum, or without a cause. As we are told in Proverbs 26:2, "so the curse causeless shall not come." To put it in the most direct language, those historical Three Angels of Revelation chapter 14 beginning with verse 6, and the REPEAT of the Three Angels, beginning in verse 15, beginning in 1930, is our 'boarding pass' or our 'ticket to ride' the Judicial Throne in the heavens above us, to the Marriage in Heaven, the Travelling Throne that Victor Houteff wrote an entire tract about (Tract #1), as well as Ben Roden, the same heavenly transport that was shown to Ezekiel in vision. It arrived on the Day of Atonement 1989, six months before Passover 1990. Ben Roden also wrote about this visitation of the Ezekiel Judicial Throne in the beginning of The BRANCH Message, 1955. However, the Executive phase of the Judgment for the Living was to begin that year, 1990. This is what I was shown in a photo, northward from the Mount of Olives, Jerusalem, on the second visit to Jerusalem, and in a dream that I was given in March of 1990. I have several studies, reports and summaries on this topic on my website www.theadventmovement.net, under the New Studies tab.

Passover week 1990 was the time of the official welcome of the Judicial Throne of The BRANCH (Christ) from Jerusalem when several groups of Branch members travelled to Israel in a one-year period to seek Divine guidance, through the leadership of Sister Teresa Moore, appointed by Sister Roden in November of 1986 to carry on the work of the repeat of the Third Angel after November 1986 when Lois Roden was laid to rest. Lois Roden wrote about this Judicial Throne in her study tracts, calling it "The Merkabah" Throne (The Merkav – Hebrew term) in her 1983 publications titled "Chariots of Fire" Part 1 and 2, reproduced on the website, which described the purpose and the coming of the Merkabah Throne. This expectation was WHY this event was so important to a group of Branch members in the late 1980s, those of us who still believed in the message given to Sister Lois Roden and Brother Ben Roden who also wrote on this topic. Because, as Sister Moore pressed upon us, month by month in her field letters beginning in 1987, the sealing truths for the Wavesheaf Company as taught by Ben Roden and Lois Roden, became fully operative, as the Fourth Member of the Godhead was fully revealed and presented. We were about to enter the "Seventh Step" of the Movement which was first taught by Victor Houteff. Teresa Moore shared with me and many others the need to make preparations and seek for the meaning of the final 430 year prophetic date (1990) given by Lois Roden published on her Heralds of the Morning Chart, published in 1978 or 1979. Teresa Moore called me many times beginning the summer of 1988, and for the next year, to talk to me about these events as taught by Lois

Roden and also seeking my prayerful input as to what we were to do, not knowing exactly what was to unfold at Passover 1990. We did not know prior to 1990 Passover that a Heavenly “change of ministration” was approaching. But nevertheless, that key truth was in the message given to Lois Roden. It began to be known about a month before our third trip to Jerusalem under the planning and leadership of Teresa Moore in 1989.

Each major phase of the Judgment, and its corresponding message since 1844, was accompanied by a “change in ministration” in the Heavenly Sanctuary work. An entire chapter in the Book “The Great Controversy”, chapter 24, by Ellen White is about this first major change in ministration in 1844, in the latter days, in connection to the antitypical Day of Atonement that began October 22, 1844. Ellen White first coined the term “change in ministration” in one statement she wrote in GC 427 and other statements. It was a very key and important truth, a major teaching in the early Advent Movement based on the Book of Hebrews, the wonderful message of the Heavenly Sanctuary written by the Apostle Paul. This was also the message of the Third Angel, the repeat of the Third Angel, given to Lois Roden, the coming change in ministration when the Other Divine Intercessor (Romans 8:26) was to receive the Heavenly Censer that was “cast into the earth” as Revelation 8:5 foretold. **“Cast into the earth” MEANS a “change in ministration” --- FROM HEAVEN TO EARTH**, to bring about the final ripening of the spiritual harvest under the direct and final ministration and intercession of the Divine Daughter in the Earth, the One who has “walked among the candlesticks” – the Seven Candlesticks, the Seven Churches, for 2000 years, sent down on the Day of Pentecost to guide and instruct the Seven Churches through the ages, until today.

In 1844, according to the Third Angel’s Message, it was announced (not fully understood at the time, not right away) that there would be a “change in ministration” in the Heavenly Sanctuary work, from the Holy place in the Heavenly Sanctuary work, TO the Most Holy Place, to begin the Judgment for the Dead. Each “change in ministration” in the Sanctuary work must have an announcement, a message, to herald it. It was so in 1844, then beginning in 1930, under the repeat of the First Angel (The Rod Message – WHR37) a 25 year period of warning began to the SDA Church, to the “professed people of God” that the Judgment for the Living was approaching. Ellen White stated in GC 490:

*Solemn are the scenes connected with the closing work of the atonement. Momentous are the interests involved therein. The judgment is now passing in the sanctuary above. For many years this work has been in progress. **Soon—none know how soon—it will pass to the cases of the living.** In the awful presence of God our lives are to come up in review. At this time above all others it behooves every soul to heed the Saviour’s admonition: “Watch and pray: for ye know not when the time is.” Mark 13:33. “If therefore thou shalt not watch, I will come on thee as a thief, and thou shalt not know what hour I will come upon thee.” Revelation 3:3. { GC 490.1}*

To further clarify, a “change in ministration” is the same as what took place on the Day of Atonement year by year in the earthly sanctuary service in Moses time (Book of Leviticus chapter 16), when the High Priest changed from one service to the next, from one phase of his work that day, to the next phase of priestly duties that day, even undergoing several garment changes during that day. Finally, the High Priest of that time came to the last part of the Day of Atonement service AFTER the “Goat for the LORD (YHVH)” had been offered, then finally that of the offering of the Scapegoat, the pronouncing of all the

sins of the congregation on the head of the Scapegoat, then led into the wilderness by the “hand of a fit man”. This is what the Message given to Lois Roden was all leading to, directing our attention to, in the unfolding of the Judgment for the Living.

This topic was first covered in my Passover 1990 study written that Spring of 1990. With each key phase of The Advent Movement Message(s), there had to be, according to type, a ‘change in ministration’ to announce the next phase, the next Priestly MOVE by Yahshua (Jesus) The BRANCH, to be a valid message, with time and type to prove the pedigree of the Message. There are many claims of the next message, using the name “BRANCH”, but only ONE pedigree of the (true) message which began anew in 1986, after the passing of Sister Roden. She was laid to rest in 1986 on the Mt. of Olives in Jerusalem, next to her beloved husband, Brother Benjamin Roden. We visited their resting places each of the three trips to Jerusalem in 1989 and 1990.

In 1955, after the passing of Messenger Victor Houteff, the end of The Rod Message and its announcement of the soon opening of the Judgment of the Living, then came Messenger Benjamin Roden who was given the actual TIME of the opening of the Judgment (for the Living), October 20, 1955, and the beginning of the harvest separation that began in 1960 at Passover time. That was a time of the greater ‘change in ministration’ since 1844 -- because that work had to do with “the living saints”, the living church members. The beginning of the Judgment for the Living under the Message given to Benjamin Roden was the opening of the Investigative phase of the Judgment, bringing with that message of the THIRD SEAL, the third sealing message, Jesus’ New Name, that the Wavesheaf and the 144,000 must have to be “sealed and perfectly united” according to Ellen White in Early Writings page 15. Both the 144,000 and the Wavesheaf Company must have all THREE sealing Messages to be sealed in their harvest class, BEFORE The Kingdom. The SECOND sealing message was given by Victor Houteff from 1930 to 1955. The FIRST sealing Message came under the Third Angel of 1844 through Ellen White.

THE REPEAT OF THE THIRD ANGEL – 1977 TO 1986

The climactic message to come to the Advent people was the final message of the SIXTH Angel of Revelation 14 (verse 18), the Angel with “power over fire”. Her message (Lois Roden) was the REPEAT of the Third Angel as predicted by Ellen White in several statements and two or three statements by Victor Houteff. The message brought by Lois Roden beginning in the fall of 1977 began the JUDICIAL phase of the Judgment for the Living, a “change in ministration”, a day of decision for individuals, the final great warning to those who had accepted The BRANCH Message under Ben Roden, a message bringing fearful consequences to those who would break away from the clear and pure message brought by Lois Roden’s ministry. That message which unfolded multiple key truths to prepare the Wavesheaf candidate for the “terrible ordeal” they were to pass through. In fact, in one of Lois Roden’s audio teachings which I have (copied on the website) she actually states, in a direct warning to Branch members, that the “branches would be tried by FIRE” in a very clearly worded statement. How soon this ordeal was to unfold in the movement! The Judgment for the Living had moved to the next phase beginning in 1977.

EGW:

*Satan will work his miracles to deceive; he will set up his power as supreme. The church may appear as about to fall, but it does not fall. It remains, while the sinners in Zion will be sifted out—the chaff separated from the precious wheat. **This is a terrible ordeal**, but nevertheless it must take place. None but those who have been overcoming by the blood of the Lamb and the word of their testimony will be found with the loyal and true, without spot or stain of sin, without guile in their mouths. We must be divested of our self-righteousness and arrayed in the righteousness of Christ. { 2SM 380.2}*

A great TEST was to come to The BRANCH family on earth, to PROVE who was for the message, for The BRANCH Himself and The BRANCH Herself, the true lineal message, ...OR who was for man, a man who would bring the predicted “mark of the beast” that Ben Roden warned about in BRANCH Lesson #7 page 1, the Revelation 18 Message, which would “incur the mark of the beast”. This unfolding of the “mark of the beast” came under the Sixth and Seventh Messages in The BRANCH, as seen in Revelation 14 and Revelation 18:1. These events began under Lois Roden’s ministry when a young man came into our Movement in 1981 and began the work of separation, a skillful dissimulation and subterfuge, sorrowfully drawing many Branch members away from the pure Message given to Lois Roden. The focus of her message was the Divine Family. It was a pure, beautiful, undeniable Message. Her Message was particularly attended by the Holy Spirit in its presentation, her publications and weight of evidence, beginning with a Divine visitation to Sister Roden one night at the beginning of the Feast of Tabernacles 1977. Her message set the stage for the Seventh Angel, the final fulfillment of the Second Angel’s (message) for the third time since 1844. Ben Roden’s Message was the second application of the Second Angel (repeated) in 1955 which put his Message in direct connection to the Revelation 18 Angel, presented again, the second time, in Revelation 14:17. Lois Roden’s message was Revelation 14:18, the Third Angel (the second time since 1844) in the REPEAT phase of the Three Angels’ Messages.

With this understood, the character and primary truth of Lois Roden’s Message was that of the Divine Moral IMAGE in humanity as reflected in the Divine Family Image in Heaven, that all of humanity is made in the Image thereof! This indeed was and is the Message given to the Sixth Angel (Rev. 14:18), presenting no less than the Divine DNA in the Message itself, the Divine Moral Image of male and female, and child, their DNA generation, based on the nuclear family image, father, mother, and child (son and daughter). This is the message that the New World Order has planned to destroy and now is the time, beginning at the DNA level, to eradicate humanity, to make humanity into the image of Satan’s making, perverting the workings of the RNA molecule so as to modify the DNA reproduction in the human chromosomal chain. Enter on the stage of human history the mRNA vaccine. “Come on, GET the VAX” they say. What they don’t tell the public is that the vax is an “experimental” vax, not fully tested. It is not even a “vaccine” by definition, according to several articles I have read and a legal case brought by Robert Kennedy Jr. at the U.S. Supreme Court (SCOTUS). The “vaccine” rather is classified as a “gene therapy” because it does generate its own virus (Covid virus), the variant, in the host or the vax recipient. The public has become the lab mice for the test. But the outcome is already known. There has been to date even big money giveaway drawings for those who got the vax, even a million U.S. dollars, yes, a million dollars. This was announced a few months ago on the main AM radio station in Toledo, Ohio. It was called, “Vax a Million”. What manner of insanity is this? Paying people to get the vax as well as paying company employees a hundred dollars to get vaxed. This has been in the news many times in recent months. Other money giveaways have been done across the USA. Now we embark into the time that Ellen White warned of “the final events will be rapid ones” and that the “mark

of the beast still remains to be defined. {GC 445.2}. Now that we understand the last in the sequences of the SIX Angels of Revelation 14, the direct connection to the human DNA, this final unfolding of events, we can see why the recent events are what they are. We can see why the enemy of souls has marshalled the latest bio warfare of our time, the most advanced biologic science since before the Flood, to change humanity into the image of the beast, into the enemy of souls.

On the first page of this study-report we are presented with the familiar Matthew 20 chart by Victor Houteff of all the Heaven-sent messages since the beginning of sacred history, nearly six thousand years ago. The Messages depicted in the light part of the day beginning with Moses and the Tribes of Israel were the type, ending with the Second Adam on the Cross 2000 years ago. The antitype messages begin under the SIXTH hour portion of the parabolic clock unfolded in Victor Houteff's Message. These are the Messages we must be familiar with to know where we came from, the first seal Message of 1844, the Third Angel, ... beginning with the Message given to William Miller, the First Angel in 1831. This chart depicts more than any other of The Rod charts -- the line of Messages that we are tested and then sealed to become the Firstfruit class of the harvest. Ben Roden drew a chart also that shows even greater detail in the development of the Messages, that I will share another time.

Now we are confronted with the events that the beast power is pressing upon every western nation in particular -- to "get the vax", to alter our genes, to ruin the Divine Image at the DNA level. The main-stream culture today has already brought moral ruin to the younger generation, through their parents, through the educational system and pop-culture.

Those who have not been grounded in the Messages of Revelation 14 have in large part fallen for or acclimated to the tremendous moral change in modern culture that the main-stream media has been pressing upon everyone for over 50 years since the counterculture revolution of the late 60s and 70s.

Counter moral indoctrination since the late 1960s, the Jesuit counter reformation at work, cultural, social, spiritual and now biological.

Even the SDA Church has had to change their moral stance on some very important cultural ideas, cultural and biological based norms of society, such as human gender, reflected in church policy today. But now it is far more change that is being forced upon western culture and the population in general, that of change of our DNA structure with all manner of unclean and spiritual corruption in the vaccination itself. Most SDA Church leaders have accepted or been forced to accept the massive cultural changes so to maintain church legal, tax status as a church 501c-3 corporation, to manage legal risk, legal but not moral, to maintain their economic interests as well as popular perception as an acceptable and compliant church body, compliant with national laws and popular culture that is variant from and hostile to the moral nuclear family image made in the Divine Image. Such church policies separate the church from our Divine foundation in truth and moral teaching, the Divine Source, under the original Third Angel's Message of 1844. There was a "separation" "from the popular churches" in the summer of 1844, under the Second Angel's Message bringing the movement to a separation from the popular

churches then, and today the SDA Church may be included since they have taken on the same policies of the mainstream Sunday churches under the same legal-governmental requirements as a corporation. Ben Roden's Message (the repeat of the Second Angel) brought a "separation" among Davidians, a literal separation from Florence Houteff and her council as well as separation from the subsequent false Davidian groups (associations) that came up after Florence Houteff's failed association. The Second Angel's Message is a Message of "separation". This is also the Message of Revelation 18:1, 2, the Seventh Message since 1844.

Remember, any purported new message, IF it does not present TIME and TYPE for its claim, and moreover, if it is not announcing a new phase of the Judgment of the Living, or one of the FOUR changes in ministration since 1844 (1844, 1955, 1977, 1990), ... then it is without spiritual pedigree, or without spiritual provenance of truth, without prophetic lineage in the line of messages, all seven messages. Any message that is about a man, or a woman, about a fellow servant, or about the purported messenger himself, be assured it is not a sealing message. We are not sealed to a man or a woman, but to a message, by a message. Overall, such a message is a test in itself, to separate true brethren from false brethren, to separate the movement into harvest bundles according to the Matthew 13 parable, those who look to man for their sealing and eternal destiny. Even though there are only THREE STEPS in the overall Advent Movement since 1831, or 1844, there have been SEVEN Messages, Six Angels brought to view in Revelation 14 and the Seventh in Revelation 18:1, each one a test to bring us to the next and final step, the next phase of the judgment, the next 'change in ministration'. The BRANCH message, being the LAST Message, the THIRD STEP since 1844, had within it THREE Messages, three messengers. The Wavesheaf are brought to a testing, a purification and trial to gain the seal for the living saints in the Waveheaf Company. In fact, as Ellen White wrote in one statement, some members of the Wavesheaf class, go through "a terrible ordeal". And indeed, we have, since the passing of Benjamin Roden in 1978 and Lois Roden in 1986.

OUR DELIVERANCE

V.T. Houteff:

The cause of the fear here forecast is fundamentally needless and unnecessary, declares the Lord. {1TG47: 14.2}

Jer. 30:7 -- "Alas! for that day is great, so that none is like it: it is even the time of Jacob's trouble, but he shall be saved out of it." {1TG47: 14.3}

***The people that have come to this antitypical time of trouble are returning to the homeland, are comforted. Apparently it is bad enough to frighten all, but God's encouraging counsel is, "Fear not."** {1TG47: 14.4}*

*Plainly, the burden of this chapter is concerning the antitypical returning to the homeland. Though terrible the trouble may seem, yet the outcome of it is to be the same as in the type. **Right now we may not appreciate this study as we ought to, but the time is soon coming in which we will dig as fast and as hard for it as we would to get out from under an avalanche.** Those who have but little faith in the Word of God though, the study will not do them much good. Now is the time to start cultivating the faith we need to have then. {1TG47: 14.5}*

Jacob, our type, well knew that God had directed his return from Padanaram to the homeland, yet he trembled when he heard that Esau, with four hundred men were on the way to meet him. Besides, he was led to wrestle with the angel all night long. He prevailed only because he would not let the Angel go until He blest him. The final result was that on the morrow, Esau, rather than destroying the whole company, very kindly greeted Jacob with a kiss, and cordially invited him to return home! So when it all worked itself out, Jacob plainly saw that there was no need at all to have ever feared. How encouraging that "all these things happened unto them for ensamples: and they are written for our admonition, upon whom the ends of the world are come." 1 Cor. 10:11. That which happened to Jacob is sure to happen to us, and how comforting to know all this ahead of time. Now, if never before we should see that where there is a type there is also an antitype, and that where there is no type, there is no Truth. {1TG47: 15.1}

*Jer. 30:8 -- "For it shall come to pass in that day, saith the Lord of hosts, **that I will break his yoke from off thy neck, and will burst thy bonds, and strangers shall no more serve themselves of him.**" {1TG47: 15.2}*

This verse plainly says that God is to free His people from the Gentile yoke, and that strangers [unconverted] shall no more trouble them. {1TG47: 15.3}

Jer. 30:9 -- "But they shall serve the Lord their God, and David their king, whom I will raise up unto them." {1TG47: 15.4}

No longer shall the followers of Truth serve others, but they shall serve the Lord, and a king whom God Himself shall provide. {1TG47: 15.5} End quote.

Each one must choose to follow their king – to follow a fallen human today, or follow a Member of the Godhead, The One who came down 2000 years ago. The King will come forth. Expect it. Pray for it.

The Assyrian power will fall. The Gentile “yoke” of the Assyrian will be broken. All of their plans to infuse our blood with their carefully designed DNA destroying substances that would destroy the Divine Image in each of us -- will not prevail against the harvest classes of the Firstfruits.

The BRANCH - The LORD (YHVH) Our Righteousness -- Jer. 23:5,6 33:15, 16 Summary of the Godhead Revelation– 1986 Until Today

The revelation of the Four Members of the Godhead, fully represented in The Son and The Daughter of Heaven, our Kings of Righteousness, our Redeemers, The BRANCH-He and The BRANCH-She, was spoken audibly to Sister Teresa Moore in 1986 encapsulating the revelation of the Third Angel in our day from 1977 to 1986. This revelation was confirmed to Sister Moore the day of Sister Lois Roden’s passing, November 11, 1986. This was the revelation of the Third Angel repeat phase through the teaching of Lois Roden, from 1977 to 1986. This was and is the “revelation of the Holy Spirit”, the Fourth Member of the Godhead, as Ellen White wrote to pray for in Volume 8:251. This is the revelation of the Godhead (Romans 1:20) that Sister Roden worked tirelessly for 9 years to present to The Branch membership.

The revelation of the Fourth Member of the Godhead was to be incorporated into The Branch Organization name beginning immediately after Sister Roden’s passing. This was the revelation of the “God Family” – The Father Most High, The Mother Most High, The Son, The Daughter. Each Member of

the Godhead with Their Counterpart. The Masculine Members (Father and Son) with Their Counterpart, El Shadai AND The Shekinah Glory revealed.

Always a "PAIR" in the Godhead. Nature follows the Divine Image.

The Father Most High has His Glory – The Mother El Shaddai (The Mighty Breasted One)– Mother Mercy. The Son of the Most High with His Glory – The Shekinah Glory – The Divine Daughter. This is the revelation of the Godhead presented to Sister Lois Roden, then fully codified in The BRANCH message through Sister Teresa Moore, appointed by Sister Roden in her Last Will document (along with Sister Irmine Sampson). That document was sent to me in 1986 by Doug Mitchell shortly after Sister Roden's passing.

Teresa Moore, that very day, inquired of Heaven of this capstone of truth as was taught by the Third Angel repeat, Lois Roden's message, and she was told -

"(you shall be called) LORDS OF SABAOTH – OUR RIGHTEOUS BRANCHES"

Without this foundation Message, the Third Angel REPEATED (Revelation 14:18 – Lois Roden's Message), there can be no message today. There can be no message if the foundation is swept away, pushed aside, de-emphasized or forgotten. The message is not about a messenger but about The Godhead. There is a Wavesheaf Company and they will be brought forth, gathered, when the King, The Bride of The Son, comes forth from "Her Closet" (Joel 2:16). This is before the Marriage in Heaven.

This revelation began the "Seventh Step" (1SR127) in the Movement, Revelation 18:1,2, from November 1986 to Passover 1990, April 1990. Now it is time to give "power and force" to the Third Angel as it "swells to a (the) Loud Cry".

Angels were sent to aid the mighty angel from heaven, and I heard voices which seemed to sound everywhere, "Come out of her, My people, that ye be not partakers of her sins, and that ye receive not of

*her plagues. For her sins have reached unto heaven, and God hath remembered her iniquities.” This message seemed to be **an addition to the third message, joining it as the midnight cry joined the second angel’s message in 1844.** The glory of God rested upon the patient, waiting saints, and they fearlessly gave the last solemn warning, proclaiming the fall of Babylon and calling upon God’s people to come out of her that they might escape her fearful doom. { EW 277.2}*

“In reviewing our past history, having traveled over every step of advance to our present standing, I can say, Praise God! As I see what God has wrought, I am filled with astonishment and with confidence in Christ as Leader. We have nothing to fear for the future, except as we shall forget the way the Lord has led us, and his teaching in our past history. We are now a strong people, if we will put our trust in the Lord; for we are handling the mighty truths of the word of God. We have everything to be thankful for.”—The General Conference Bulletin, 1893, 24 (see Life Sketches, 196; Testimonies to Ministers and Gospel Workers, 31). { 3SM 162.3}

Closing Testimony

Remember the Messages left to us by Benjamin Roden and Lois Roden, the Fifth and Sixth Angels messages, these two in particular, the final messages (third step since 1844) -- the conclusion of the SIX Revelation 14 Messages. Then comes the “power and force” Angel, Revelation 18. This is our lineage, how we are to identify the true, with the pedigree of time and type.

I well understand that some of the recipients of this report and study, of the few I have sent to, a dozen names more or less, may have little interest in all of this, or none at all, of the events presented and my burden of the shortness of time we all have with developing events in prophecy and the nearness of the Firstfruit harvest. I hope or pray that will change. We all know too much of the message(s) to stop now or be disinterested. Each one is accountable for the knowledge and experience we have had, more so of those of us who knew Ben Roden and Lois Roden personally. The www.theadventmovement.net website is the only resource online, certainly that I know of, that provides the original BRANCH message of the Fifth and Sixth Angels Messages of Revelation 14. I encourage everyone who came up in these last two messages to regularly read from Ben Roden’s and Lois Roden’s publications on the website to know where we are in present events and know our standing with the message and our standing with Heaven to grow in Grace and Knowledge. Remember, it is the Messages that SEAL us for the harvest. We are not sealed to a man or woman, or a messenger, but to a Message. The Messages are just as real today as if the messengers who gave them were still alive today. The foundation are everything in the sealing. It was heart rending to me and to others I know, to see many I/we knew perish in the judgment at New Mt. Carmel in 1993 at Passover time, just after. But today, under the interim leader of those that remain of “the survivors” of Waco, as they are called, the one they regarded as “messiah” “king”, even “God in the flesh”, though dead and buried, is still regarded as what he claimed to be, watching over his people from on high, supposedly, and soon to return and bring judgment, in their hope, upon all the unbelievers and the government that murdered 84 of them, ending their message and their headquarters. They care(d) nothing about the foundational messages from 1844 to the present. With this shared, I will leave this closing thought with everyone. Early on the morning of 9/17, late last week, I had, or was given, two dreams the same night, several hours apart, very unusual, on the same topic, relating to two well-known personalities, presenting different outcomes or different versions of events with each dream, pertaining to New Mt. Carmel, Waco as it is today. I will not relate the actual dreams but give what I believe is the outcome or soon judgment upon the current occupants there, who completed the "mark of the beast" in the movement, bringing in Sunday sacredness in 2011, the final blow to the message or the movement which was predicted by Victor Houteff and Ben Roden. I wrote down the dreams and shared them with Linda. The dreams were about a second judgment to come there at New Mt. Carmel, a major destruction, because of what the current owners of the property did, the serious crime committed, going back to December 1989, which I will not relate here. In our history for the last 33 years, the first predicted judgment was the fiery holocaust on the Koresh faction in April of 1993, a complete destruction of the building, the "compound" of the false headquarters of the "beast" power then, bringing it to an end, as predicted by Ben Roden --- a false messiah who was elevated as "Messiah" and "King". One thing I know, or believe, that a second major judgment there cannot be long deferred. The BRANCH, who is Christ, is not mocked. What the current leaders there have committed must be visited by judgment. We will see what the Hand of judgment of Divine Providence will do. "Judgement must first begin at the house of God." 1 Peter 4:17.

Be Ready. Watch, pray, pray for each other and study as best you can, make time. There is no such thing as an unlearned or ignorant Firstfruit.

May each Branch-Wavesheaf member be prepared for the Day of Atonement, October 2 (sundown October 1) according to the Solar Calendar as depicted on Victor Houteff's Sacred Feast Chart. The High Holy Days begin in the Fall season year by year, beginning 9/22, Yom Teruah, Feast of Trumpets, the day after the Autumnal Equinox. If any have already kept the Day of Atonement this year, this last week according to the Jewish (rabbinic) calendar, then you have kept the Day of Atonement out of season, since the rabbinic Jewish calendar observed it a few days before the Autumnal Equinox, and Yom Teruah – Feast of Trumpets, nearly two weeks before the Equinox, which is often the case, with Day of Atonement and Passover observances. The Fall Feasts are in the Fall. The Spring Feasts are in the Spring, not a few days before. Day of Atonement is in the Fall, not summer. No wonder Victor Houteff stated that the Vernal Equinox is "the immovable signpost". If you, or the calendar authorities of Judaism, move "the signpost", or modify it according to the "lessor light" of the heavens, then there is no sign, no signpost. Signposts are meaningless if moved, particularly a STOP sign. Man cannot tamper with or change the "signpost". The "sign" always marks the seasons along with the solstices. The moon will be restored to its former function, to "rule the night" soon, and as the second witness in the heavens to mark the four "seasons" and the Moedim (Feasts). The Sun and the Moon were to work together in the beginning and will again in the "restitution of all things" (Acts 3:19-21). Sorry this report has run longer than intended but much has happened in the last six months and the last year and much is going to happen soon as we can see final events developing before our eyes almost daily.
